

## SAN SABA CITY ORDINANCES

Keep San Saba Beautiful would like to remind you of the City Ordinances that help keep our city clean and safe for all residents. For more details concerning City Ordinances contact the City Code Enforcement Officer at 325-372-5144

### WEEDS, RUBBISH, BRUSH, OR OTHER OBJECTIONABLE MATTER:

It shall be unlawful for any person, firm or corporation who shall own or occupy any lot or lots in the city to allow weeds, rubbish, brush or any other unsightly, objectionable or unsanitary matter to accumulate or grow on said lot or lots.

### ACCUMULATIONS OF STAGNANT WATER:

It shall be unlawful for any person, firm or corporation who shall own or occupy any lot or lots in the city to permit or allow the accumulation of stagnant water thereon, or to permit same to remain.

### UNWHOLESOME MATTER:

It shall be unlawful for any person, firm or corporation who shall own or occupy any house, building, establishment, lot or yard to allow any unwholesome matter to accumulate or remain thereon.

### JUNK VEHICLES:

It shall be unlawful for any person, firm or corporation to keep, store or place junk cars, on private property or on any public street, alley, sidewalk, or side or back yard without being screened from public view (tarps are not acceptable cover) or other public place within the corporate limits of the city.

### REMOVAL OF SIGNS AND NOTICES:

All signs, notices, posters, and announcements, including material/objects, pertaining to, but not limited to, political advertisements, auctions, sales and scheduled events, shall be removed within ten (10) days at the conclusion of said event. The placement or installation of signs in the right-of-way of any street, alley, utility pole or public property is prohibited. See next column for garage sale sign rules.

## SAN SABA CITY ORDINANCES

**GARAGE SALE:** ("GARAGE SALE" refers to all sales- Lawn Sale, Attic Sale, Rummage Sale, Flea Market Sale, or any similar casual sale.)

It shall be unlawful for any person to conduct a garage sale within the city limits without first filing with the city secretary and obtaining a permit to do so, to be known as a garage sale permit. A garage sale permit shall be issued to any one person or location only six (6) times within a twelve-month period and no such permit shall be issued for more than two (2) consecutive calendar days. There is no charge for a garage sale permit.

### GARAGE SALE SIGNS:

Signs giving notice of or advertising garage sales in residential areas shall not exceed four square feet in face area. They may not be illuminated, may not be erected earlier than one (1) day preceding the sale and shall be removed within one (1) day following the sale. Signs will show the location and date of the sale. The placement or installation of garage sale signs in the right-of-way of any street, alley, utility pole, or public property is prohibited.
