Tony Jacobs, Jr. is requesting that the property be rezoned to Residential (R-2) One-Family Residential.

The Planning and Zoning Commission met in Open Session on May 23, 2024 and voted 4 to 0 Vote in favor of approving a Zoning Change for property located at 502 West Pierce Street, San Saba, Texas, Legal Description, Riverside Addition, Block 12, Lot 6, 20'x16' Building currently zoned Commercial (C-2) Local and Through Highway Business to be rezoned to Residential (R-2) One-Family Residential.
