# **PUBLIC HEARING**

- 1) The City of San Saba will hold a Public Hearing at this time to consider adopting a proposed budget for FY 2024-2025 and tax rate for the 2024 tax year. The proposed tax rate increased to last year's effective tax rate, \$.344000 per \$100 evaluation. Property taxes collected in 2024 will be \$30,781.00 more than what was collected in 2023 due to an increase in the total tax roll. All Citizens are invited to express their views on the proposed city budget and tax rate.
- 2) Tommy Pulatie and Mitchell Pulatie are requesting that the Planning and Zoning Commission and the San Saba City Council approve a Zoning Variance to the City of San Saba's zoning ordinance in order to install an RV Park on property currently zoned Agricultural located at CR 102, Legal Description Riverview Terrace, Abstract 421, Survey 35, a 2.25 Acre tract of land of the E. Gilman Survey being situated in San Saba County, Texas, Parcel ID 31700.

The Planning and Zoning Commission met in Open Session on September 5, 2024 and voted with a 5 to 0 Vote to not approve this Zoning Variance. The City encourages citizens to make their views known at this public hearing.

3) Greg McGregor, owner of McGregor Property Management is requesting that the Planning and Zoning Commission and the San Saba City Council approve a Zoning Change for property located at 1806 W. Wallace Street, San Saba, Texas, Legal Description West ½ of Block No. 12 of the Laurel Heights Addition to the town of San Saba, Texas, lying North of the North line of the right of way of U.S. Highway No 190, save and except and not herein conveyed the East 10 feet of said West half of Block No. 12, the

same constituting the West half of a 20 feet alley running through said Block North and South currently zoned Residential (R-2) to be rezoned to Commercial (C-2).
