RESOLUTION 2025-52**A RESOLUTION OF THE CITY OF SAN SABA TO WAIVE AN
ORDINANCE DEFINING NOISE NUISANCES**

WHEREAS, the City of San Saba desires to regulate and oversee any unreasonable loud, disturbing, unnecessary noise which causes material distress, discomfort or injury to persons of ordinary sensibilities in the immediate vicinity.

WHEREAS, the playing of any radio, phonograph or other musical instrument in such manner or with such volume, particularly during the hours between 10 p.m. and 7 a.m. as to annoy or disturb the quiet, comfort or repose of persons of ordinary sensibilities in any dwelling, hotel or other type of residence is prohibited.

WHEREAS, **Pilar Rosales, 205 W. Annex, San Saba, Texas**, has asked the City Council to waive Ordinance No. 1967-4 to allow music to be played at the Mill Pond Gazebo on December 13th, 2025, until 12:00 midnight.

NOW THEREFORE BE IT RESOLVED, that the City Council of the City of San Saba is hereby authorizing the playing of music from 10:00 to 12:00 midnight on December 13th, 2025, at Mill Pond Gazebo.

The first discussion/action item was to Discuss, consider, and take possible action approving Resolution No. 2025-53 a Resolution of the City of San Saba, Texas regarding a Memorandum of Understanding between Richland Springs ISD Police Department and City of San Saba Police Department and authorizing the City Manager of the City of San Saba Texas to sign said agreement as the authorized representative of the City of San Saba, Texas. RESOLUTION NO. 2025-53**A RESOLUTION REGARDING A
MEMORANDUM OF UNDERSTANDING
BETWEEN RICHLAND SPRINGS ISD POLICE DEPARTMENT
AND CITY OF SAN SABA POLICE DEPARTMENT**

WHEREAS, the City of San Saba desires to enter into a Memorandum of Understanding between the City of San Saba Police Department and Richland Springs ISD Police Department in order to plan, communicate and coordinate efforts in the event of an incident, minor or major, on the Richland Springs ISD campus, San Saba ISD campus(s) or within the boundaries of the Richland Springs ISD or the San Saba ISD;

WHEREAS, the City of San Saba finds that the City of San Saba Police Department entering into a Memorandum of Understanding with the Richland Springs ISD and Richland Springs ISD Police Department serves a public purpose and benefit to any and all citizens within each jurisdiction and District as well as the entire County of San Saba.

NOW THEREFORE, BE IT RESOLVED BY THE CITY OF SAN SABA & SAN SABA POLICE DEPARTMENT and the **RICHLAND SPRINGS ISD & DISTRICT POLICE DEPARTMENT** in consideration of the mutual covenants and agreements herein contained, do mutually agree as follows:

Section 1. That the City of San Saba & San Saba Police Department will enter into a Memorandum of Understanding with Richland Springs ISD & District Police Department.

Section 2. That the Memorandum of Understanding approved as of December 9, 2025, by and between the City of San Saba & San Saba Police Department and Richland Springs ISD & District Police Department **TERMS** as described in **Exhibit "A"**.

Section 3 That the San Saba City Council will designate Scott Edmonson, City Manager, as the authorized signer of the Memorandum of Understanding as approved by the San Saba City Council on December 9, 2025, by and between Richland Springs ISD Police Department and City of San Saba Police Department.

PASSED AND APPROVED by the Council of the City of San Saba in a meeting held on the 9th day of December, 2025.


Wayne Yarbrough, Code Enforcement Official reported: thanked the City and gave a brief exit statement about his forty years of service with the City.
